Nurse's Week 2023 TravCon Raffle Official Entry requirements, Terms and Conditions

## **Program Overview**

To help celebrate Nurses Week, Epic Staffing Group will award two separate winners a trip to **TravCon 2023** (September 17 – 20, 2023), to Epic Travel Staffing Nurses or Interim subject to the terms and conditions set forth herein.

All Nurses or Interim that worked for Epic Travel Staffing during 2023 are eligible to enter a random drawing to win the prize. To qualify for the drawing, entrants would need to have started or completed at least one qualifying staffing assignment in 2023 (if the staffing assignment started in 2022 and ended in 2023, they are qualified). An assignment is considered qualifying if at least 8 of the 13 weeks were completed, and there was no termination for cause. The odds of winning depend on the number of eligible entries received.

The raffle will be promoted via email, website, and social media during May 11–19, 2023. To enter, candidates must complete and submit an online form, which will be provided via email, social media and made available at <a href="https://www.epicstaffinggroup.com">www.epicstaffinggroup.com</a>.

To qualify for the drawing, entries must be completed and submitted by 11:59:59 p.m. Eastern Daylight Time, Friday, May 19, 2023.


Winners will be announced on or about: Wednesday, May 24, 2023.

Winners must acknowledge and confirm attendance by 11:59:59 p.m. Eastern Daylight Time, Wednesday, June 7, 2023.

If the selected winner(s) does not acknowledge by this time, another winner will be chosen from a new random drawing.
